Reinstatement Policy as Stated in the Academic Regulations: Students academically suspended from the university will be considered for reinstatement to the university after two years or after completion of a minimum of 24 quarter credits of transferable college level work at an accredited college or university with a GPA of 2.5 or above.

Deadline: Reinstatement applications must be submitted to the Office of the Registrar two weeks prior to the term reinstatement is requested. If your reinstatement depends on transfer work from the term preceding, you may submit your application and transcripts no later than the first day of the term reinstatement is requested.
